Terms & Conditions

Promiseland Productions has a two installment payment plan for wedding video and wedding photography services. A non-refundable deposit of 20% is payable upon booking your wedding event with Promiseland Productions. The final balance is due at least 2 weeks prior to the day of the wedding event.

Promiseland Productions requires a 50% deposit for all other video and photography services upon booking, of which 20% of deposit amount is non refundable. The remaining 50% is due 2 weeks prior to scheduled event date. In the event that more than one client wishes to book Promiseland Productions services on the same day, preference will go to the first client to pay the deposit. Rescheduled events will only be accommodated if the new date does not conflict with other booked events.

It is the client's responsibility to secure access to areas for videography/photography. Promiseland Productions will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of Promiseland Productions. Promiseland Productions will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, etc.

Promiseland Productions reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

Upon taking possession of the finished product, the client must inform Promiseland Productions of any technical problems, e.g. playback of delivered material or misspells with the video within 7 days. Any re edits of video may require additional cost. Upon 7 days, if no notification has been received, the client will be deemed to be satisfied with the product. The entire video editing process can take up to 4-8 weeks to be completed, contingent upon event project.
